- A. Lakewood School District Contract is amended to increase the Contract award amount by \$3,000 to include program improvement funds. The maximum consideration of this Contract is now \$186,000.
- B. Exhibit A, Specific Terms and Conditions, is changed in its entirety and is superseded by Exhibit A-1, as attached. Changes include:
 - 1. Section I. Removed reference to Child Care Development Fund (CCDF);

 - 5. Section XI.A. Added language on timeline for existing sites for Early Achievers remedial activities;
 - 6. Section XI.B. Changed deadline to register for Early Achievers in MERIT;
 - 7. Section XI.C.1. Added language on timeline for new sites for Early Achievers remedial activities;
 - 8. Section XI.C.2. Added language on continuation of services for new sites rating below Level 4 after completion of remedial activities;
 - 9. Section XI.F. Added County access requirement for all Early Achievers documents for licensed child care sites;
 - 10. Section XXII. Removed requirement to submit advertising and publicity matters to the County;
 - 11. Section XXII.B. Clarified language on acknowledging credit for funding sources (Department of Early Learning and County);
 - 12. Section XXIV. Removed reference to interest-bearing accounts;
 - 13. Section XXIV.B. Added submission of the Financial Disclosure Certification and Staff Compensation Data;
 - 14. Section XXIV.H. Clarified language on travel expenses and updated the State website link;
 - 15. Section XXIV.J. Clarified language on child care subsidy billing for Full School Day and Extended Day models;
 - 16. Section XXIV.J. Removed reference to CCDF;
 - 17. Section XLI. Deliverables has been updated; and
 - 18. Section XLIII.B. Added "policies" to State documents.
